General

References in this privacy policy to "we", "our" and "us", etc. are references to us, Dimension 3 Pictures Ltd, Registered Company no. 06536283.

We are committed to protecting your privacy and respecting the confidentiality of information which you provide when you visit our website at www.d3pictures.com. At the same time, we want to try to ensure that you obtain full value from our website and from the services which you may want to receive via our website.

We uphold the relevant data protection principles and process all personally identifiable information about you ("personal data") in accordance with the 1998 Act and other relevant legislation. This privacy policy explains what information we may collect about you when you visit our website and how we may use it.

The information we collect

It is possible to use our website without providing any personal data. In some areas of our website we may ask you for personal data, such as your name, and e-mail details, that will enable us to make your site visit a more rewarding experience for you and/or to contact you after your visit.

How we may use this information

We will not disclose any of your personal data collected via our website to any third party, other than in circumstances set out in this privacy policy and/or where you have given us permission to do so, unless we are required to do so by law.

We may use personal data collected from you via our website to manage and monitor use of our website. Otherwise, we will only use this personal data for the purposes for which it was collected, unless you have given us permission to use it for other stated purposes.

There may be circumstances in which we will ask you to agree to us disclosing your personal data to certain third parties, or transferring it outside the United Kingdom. However, we will not do this without your permission. However, before transferring your personal data in these circumstances, we will do our best to ensure that appropriate arrangements are in place to protect your privacy.

Cookies

When you visit our website we may send "cookies" to the browser on your computer, even if you do not provide us with any personal data. Subject Access Requests
